## Bring It Home Voucher Program Waiting list

Applications will be accepted beginning Wednesday, February 11, 2026.

Applications will be available in the Aitkin County Housing and Redevelopment Authority (HA) office or online at [www.aitkinhra.org](http://www.aitkinhra.org). Applications will be accepted at the HA office, via fax, or emailed to [general@aitkinhra.org](mailto:general@aitkinhra.org).

The Bring It Home (BIH) Rental Assistance program is a new program funded through MN Housing to create rental assistance for low-income families across Minnesota. This is a tenant-based rental assistance program where tenants pay approximately 30% of their income towards their rent. The Aitkin County HRA BIH subsidy can only be used in Aitkin or Mille Lacs Counties, Minnesota and cannot be transferred to another housing authority for assistance in a different city.

Households are eligible to apply for the Aitkin County HRA BIH program if they:

- Are a Minnesota resident;
- Have an annual income of up to 50% of the area median income (AMI) as determined by the United States Department of Housing and Urban Development (HUD), adjusted for family size;
- Pay more than 30% of the household's annual income on rent;
- Are not receiving federal tenant-based assistance under Section 8 of the United States Housing Act of 1937, as amended; and
- Are not currently in a unit receiving project-based assistance under Section 8 of the United States Housing Act of 1937, as amended

In order to qualify, the annual gross household income cannot exceed 50% AMI.

**Preference Eligibility**

- Have a child or children aged 18 years or younger in the household
- Indicate intent to use the subsidy at your current residence in Aitkin County or Mille Lacs County

Applicants can only be on one application. Applications must meet income and eligibility requirements. Applicants will be placed on the waiting list according to the preference(s) for which they qualify, and the date and time randomly applied to the applications.

If selected for the program, applicants will be notified in order of their placement on the waiting list to be screened for eligibility. Applicants do not need to be current Aitkin County or Mille Lacs County residents to apply, but the Aitkin County HRA Bring It Home subsidy can only be used in Aitkin County or Mille Lacs County, Minnesota.
